I agree and fully understand that:

- A. Risks and dangers exist when participating in the boat parade. Risks include but are not limited to injury, illness, strains, fractures and loss of life.
- B. These risks and dangers may be caused by the negligence of others, forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; and
- C. By my participation in said event, I assume all risk and dangers and all responsibility for any losses, thefts and/or damages that are not directly attributable to gross negligence on part of the organizer or anyone affiliated with the event.
- D. I have adequate boat insurance to cover myself, and others, should an accident occur.

I, on behalf of myself, my personal representatives, and my heirs hereby voluntarily and knowingly agree to remiss, release, forever discharge, hold harmless, deferred and indemnify event organizers from any and all claims, actions, causes of actions, suits, judgments, claims and demands for bodily injury, property damage, loss of life, and/or loss of services, in law or equity, that may in any way or manner arise from any accident, incident, happening, circumstance or activity or otherwise may arise out of my use of the equipment. Barring gross negligence on part of the organizers, I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for ordinary negligent acts or human error.
